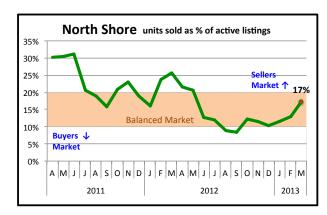

## market update

The Real Estate Board of Greater Vancouver (REBGV) reported total MLS® residential property sales of 2,347 units in March representing a 31% increase over sales in February, and 18% fewer than in March 2012. At 15,460, the total number of residential property listings at March 31 was 5% more than at the end of February, and 2% more than at the end of March 2012. The metro MLS® sales-to-active-listings ratio of 15% is up from 12% last month, and is the first time this ratio has been above 15% since May of last year.



North Shore home sales in March, at 283 units, were 41% higher than in February, and 21% fewer than in March 2012. The sales to active listings ratio on the North Shore rose to 17%, from 13% in February, reflecting a noticeable improvement in local market conditions. North Shore single-family homes that sold In March took an average of 84 days to sell, or two weeks less than the average of 99 days for February's sales, although more than 3 weeks longer than the

average of 61 days for houses that sold in March 2012. At March 31, there were 1,632 North Shore properties listed for sale (on MLS) or 6% more than the 1,541 listings at the end of February, and 17% more than the 1,392 units for sale at March 31, 2012. Compared to March 2012, benchmark prices of detached single-family homes were down by 4.9% in West Vancouver and by 2.4% in North Vancouver, and both have dipped by 2-3% in the past six months.

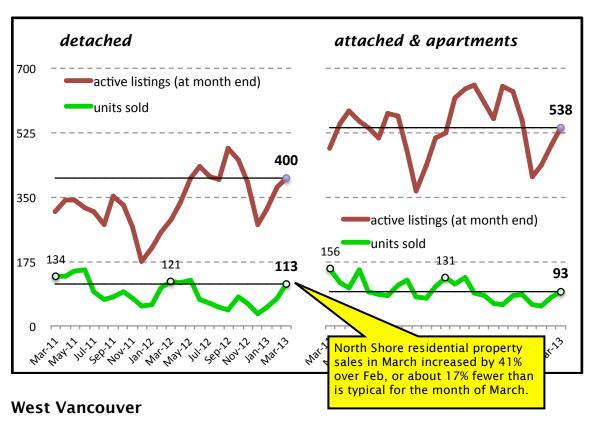

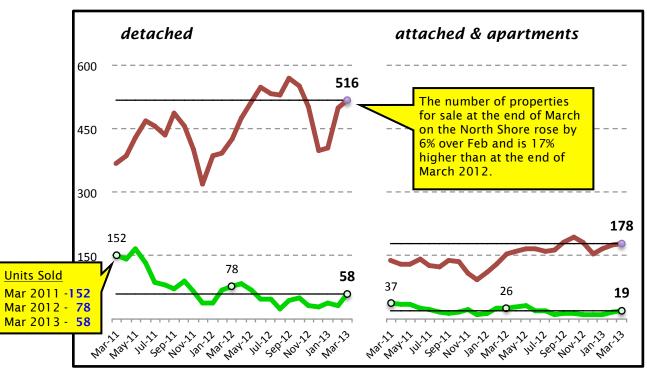




The following charts show the inventory of North Shore homes for sale on the last day of each month from Mar 2011 to Mar 2013, and the sales for each month.

#### **North Vancouver**

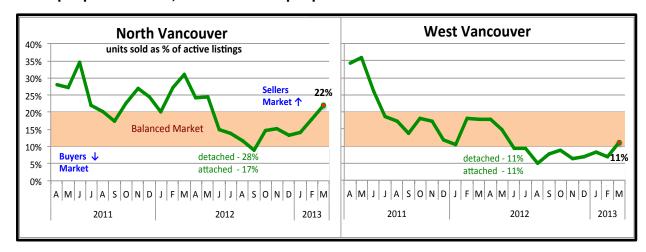




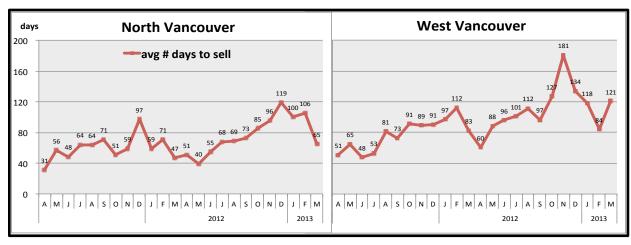

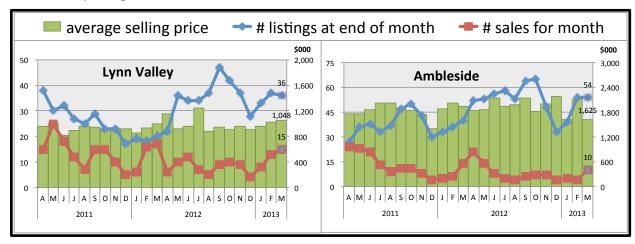
#### properties sold, as a % of # of properties for sale at end of month

### returning to GST-PST

Wondering how the return to a GST-PST world will impact housing transactions? You're not alone!

As was the case with 12% HST, the 5% federal GST only applies to the purchase of properties that are newly constructed or substantially renovated, and the 7% provincial portion of the HST no longer applies at all. A reminder, neither HST nor GST apply to purchases of properties that are not considered to be new housing.

Builders will be charged the new 7% provincial PST on most of their building supplies.

There is a new, temporary 2% BC transition tax on purchasers of certain newly constructed or substantially renovated housing purchased between April 1, 2013 and April 1, 2015. More specifically, this new tax applies to purchases of new homes that are at least 10% completed before April 1, 2013 and where either ownership or possession transfers before April 1, 2015.

There is some relief to buyers as a lower 5% GST replaced the old 12% HST that was charged on amounts related to purchases of new **and** resale properties, such as real estate commissions, and fees to lawyers, notaries, building inspectors and lenders.
